The following is not required of a nominee but can be used in the evaluation process:

- Actively promotes the Platinum Individual[™] designation, training, and a positive image of the collision industry (locally or on a broader scale)
- Active in a local volunteer committee, ISAC, or NFAC, etc.
- Active in inter-industry in other organizations or associations
- Active in local community

Please note all current I-CAR employees are not eligible to earn this award, with the exception of I-CAR instructors.
